## ACCESS PLAN 2017 - 2020



The SEN and Disability Act 2001 amended Part 6, Chapter 1 of the Equality Act 2010 by introducing new duties on LAs and schools in relations to disabled pupils and prospective pupils.

The responsibility for the Access Plan lies with the governing body and the Headteacher. In terms of the day to day management of the Plan responsibilities lies with the SENCo.

In the long term the intention is to ensure that the School is wholly accessible in curricular, premises and communication terms to all the people who may be served by it. To this end we will focus on all access strategies which will aim to overcome some of the barriers to leaning or participation experience by disabled people served by or serving the School.

Should any prospective child or member of staff be in need of premises adaptation the governors will inform the Local Authority immediately.

The attached grid outlines the short, medium and long term targets which are designed to assist us towards our stated objectives.

Adaptations to be either funding from school capital funds or the LA Schools Access Initiative as and when needs arise.
